The governing body of the City of Syracuse met in regular session on March 9, 2015 at 5:00 p.m. in the City Clerk's Office. Councilmembers present were: Michele Boy, Vance Keller, Steve Schell and Mayor, Dustin Doze. Employees present were: Brian Bloyd, City Administrator, Linda Dinkel, City Clerk, Sarah Carter, City Treasurer, and Rob Gale, City Attorney. Leslie Carlholm, Marcus Ashlock, and Marshall Hart were also in attendance. Councilmember Matt Gould was not present.

The meeting was opened by reciting the Pledge of Allegiance.

Councilmember Boy made motion to adopt the agenda. Councilmember Schell seconded the motion and all councilmembers voted aye.

David Stimatze, Fire Chief, joined the meeting

Councilmember Boy made motion to approve the minutes of February 9, 2015 as presented. Councilmember Keller seconded the motion. Minutes were approved with all members voting aye.

Councilmember Schell made motion to approve appropriation ord. #908 in the amount of \$76,701.58, Councilmember Keller seconded the motion. Appropriation ord. #908 was approved unanimously.

Ordinance Number 683, AN ORDINANCE FIXING RATES FOR WATER AND REPEALING ORDINANCE NO. 667 AND ANY OTHER ORDINANCES OR PARTS OF ORDINANCE IN CONFLICT WITH THIS ORDINANCE was read section by section and as a whole. Councilmember Schell made motion to adopt ordinance no. 683. Councilmember Keller seconded the motion and it was passed with all councilmembers voting aye.

Ordinance Number 684, AN ORDINANCE AMENDING ARTICLES IV OF ORDINANCE NO. 562 AND REPEALING ORDINANCE NO. 668 AND ESTABLISHING NEW CLASSES OF USERS AND CHARGES TO USERS OF THE CITY'S WASTE-WATER TREATMENT WORKS FOR THE CITY OF SYRACUSE, COUNTY OF HAMILTON, STATE OF KANSAS, was section by section and as a whole. Councilmember Boy made motion to adopt ordinance no. 684. Motion was seconded by Councilmember Schell. Motion passed unanimously.

Ordinance Number 685, AN ORDINANCE FIXING SERVICE CHARGES FOR THE COLLECTION AND DISPOSAL OF REFUSE WITHIN THE CITY OF SYRACUSE, KANSAS AND REPEALING ORDINANCE NO. 669 AND ANY OTHER ORDINANCE OR PARTS THEREOF THAT ARE IN CONFLICT WITH THIS ORDINANCE was read section by section and as a whole. This ordinance was tabled to the next meeting so that more research could be done.

Occupation Liquor Tax for a Class B Private Club for Crazy Horse 2, LLC was approved on motion from Councilmember Keller, seconded by Councilmember Schell and all councilmembers voting aye.

Round Table: Marcus Ashlock reported to the Council that the ads for Wild West Country should be complete by the end of the week. Mayor Doze asked about the feasibility of public restrooms at Benchmark Park.

Councilmember Keller made motion to adjourn, seconded by Councilmember Boy. Meeting was adjourned with all councilmembers voting aye.
